

24 MONTHS LIMITED WARRANTY FROM MAYTRONICS LTD

By using the pool cleaner, you accept the terms and conditions of this warranty.

This MAYTRONICS pool cleaner is warranted to be free from defects in materials and workmanship under normal use and service, subject to qualifications, conditions and limitations as described below.

[Maytronics LTD] ("Maytronics") provides a warranty covering the motor unit, cable, and power supply of your Dolphin robotic pool cleaner for a period of **24 months** from the original date of purchase, and covering all other parts of your Dolphin robotic pool cleaner for a period of **12 months** from the date of purchase. The warranty is subject to the qualifications, conditions and limitations as described below.

- *is applicable in Australia, New Zealand, Pacific Islands, South East Asia and Southern Africa;*
- *covers only normal and reasonable use of the unit;*
- *is for manufacturing defects only;*
- *will be invalidated by the use of any electrical components not originally manufactured by MAYTRONICS; and does not cover damage, defects, malfunctions or other failures caused by or related to:*

any use which does not comply with the instructions in the operator's manual, including the failure of the purchaser to provide reasonable and necessary maintenance; or repairs performed by any service station or person other than an authorized service representative of MAYTRONICS.

To obtain warranty service, contact your nearest authorized MAYTRONICS dealer with the date of purchase, serial number and description of the problem.

If a MAYTRONICS dealer instructs you to return the unit, you must attach to the unit a copy of the invoice including date of purchase, serial number and description of the problem.
